



TEAM REGISTRATION INSTRUCTIONS 2008-09 Season

Players & all team Staff must register online through the Bonzi system. Registrars will assign team members from the Team Registration form. Anyone not registered through Bonzi cannot be assigned to the team. Please **carefully read and follow** these instructions to assure a smooth team registration process. All FWUSC forms are available online at www.federalwaysoccer.com under the “Sign Up” page and may be filled out online prior to printing for clarity.

Team Registration Form (TRF) NOT TO BE USED AS A TOURNAMENT ROSTER, See website.

- Pg 1: Team Staff - Anyone directly working with the players or handling team funds must register themselves through Bonzi under **Coaches**, which includes the required Risk Management clearance.
- Pg 2: Players - Please list alphabetically by last name.

Player ‘Legal’ Playing Age – Players must register at their proper age level.

- The coach is responsible for ascertaining all players are playing in their legal age bracket
- *Only* if a player is new to FWUSC, a copy of their Proof of Age document must be included.

Acceptable Proof of Age Documents

- Birth Certificate – Certified Copy
- Drivers License
- INS Document
- Government Issued ID Card
- Passport

(If in foreign language, an official document translating it must be included)
