

LIABILITY WAIVER

RELEASE

- 1. Participants age 18 and over must complete Part A only.
- 2. Participants under age 18 must have parent or guardian complete both Parts A and B.

PART A—WAIVER AND RELEASE FROM LIABILITY

In consideration of being permitted to volunteer, participate in or being permitted to attend, compete in, officiate at, observe, work at or for any purpose participate in any Washington Youth Soccer event or activity, each of the undersigned, for himself/herself, his/her personal representatives, assigns, heirs, and next of kin, acknowledges, agrees and represents that he/she:

- 1. HAS READ, AGREES TO AND ACCEPTS ANY AND ALL CONDITIONS OF PARTICIPATING/VOLUNTEERING IN A WASHINGTON YOUTH SOCCER EVENT.
- 2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE US Youth Soccer, Washington Youth Soccer, the promoters, other participants, operators, officials, any persons in the Participation Area(s), sponsors, advertisers, owners and lessees of the premises used to conduct the event or activity, and each of them, their officers and employees, all for the purposes herein referred to as "Releasees," from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence of the Releasees or otherwise while the undersigned is in or upon the Participation Area(s), participating or volunteering and/or attending, competing in, officiating at, observing, working at, or for any purpose participating in the event or activity.

HEREBY AGREES TO INDEMNIFY, SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, cost or claim they may incur due to the presence of the undersigned while volunteering, or attending, competing in, officiating at, observing, working at, or for any purpose participating in the event or activity.
